Cooled Semen Sales Agreement for Mobolensky

This agreement is made for the 2026 breeding season by and between Suzanne McCartin (hereinafter referred to as “Stallion Owner”) and _____ (hereinafter referred to as “Mare Owner”), for _____ (mare) and the KWPN stallion “Mobolensky CM v/d Wolfshoeve”, 201701687. Mare is expected to be bred around ____ day of _____ (month).

The breeding fee for 2026 is \$1700 (includes a \$400 nonrefundable booking fee). All fees discussed in this agreement are in Canadian funds. Please check the discounts below that apply:

- 10% multiple mare discount (breeding more than one mare in the same season - \$170 value)
- 10% repeat customer discount (serviced by our stallions from any previous year - \$170 value)
- 10% premium mare discount (of excellent breeding and/or approved with a WB registry - \$170 value)

- 1) Mare Owner is granted a breeding to Mobolensky for the fee of \$_____ (\$1700 minus applicable discounts), applying to the mare described in this contract only. The first collection is included in this price. The \$400 booking fee is due upon signing of this agreement, the balance will be due prior to shipment of the semen. Fresh cooled semen is shipped in a disposable container, the cost for which is included in the collection fee. The cost of shipping is required prior to collection. Should additional collections be required, the collection fee of \$300.00 will apply to each collection as well as the cost of shipping and will be due prior to each shipment.
- 2) Semen will be shipped from Uxbridge, Ontario. Mare Owner is to contact the Stallion Owner **at least one week** prior to the expected date of shipment of fresh semen to give advance notice. Request for semen shipment needs to be made **by 3 p.m. EST via e-mail to horsepoweredtc@gmail.com the day BEFORE semen is collected and shipped**. If your e-mail requesting collection is not confirmed within one hour by the Stallion Owner, it is suggested that you call to confirm at **289-231-5682**. Semen will be shipped by FedEx overnight service. If same day service by air is required, the mare owner is responsible for booking and paying for the expedited/priority flight, the charge for couriering the semen to the airport in Toronto, Ontario is \$200. Please let us know if you need assistance with booking a flight, we are always happy to help. Same day service from Toronto may not be available to all airports & drivers may not always be available to take semen to the airport.

- 3) Mare Owner warrants that said mare is in sound breeding condition as determined by a qualified veterinarian. Mare Owner agrees that the mare will be bred by a veterinarian with considerable experience in A.I. who has access to a veterinary ultrasound machine.
- 4) Should the mare fail to be in foal after initial insemination, Stallion Owner agrees to ship cooled semen for a repeat service **AFTER** receipt of:
 - i) signed veterinarian certificate confirming that the mare is not in foal and
 - ii) payment of \$300.00 for the cost of collection plus shipping costs for the next shipment.
- 5) Both parties acknowledge that there is a live foal guarantee, for the live foal guarantee to be valid, the following conditions must be met:
 - i) A licensed veterinarian must examine the mare and advise Stallion Owner in writing of the mare's pregnancy status within 40 days after the last insemination date. If this notification is not provided, the live foal guarantee and return breeding privileges of this contract becomes null and void.
 - ii) Should the mare not produce a live foal (i.e. a newborn foal that stands and nurses), the Mare Owner is entitled to a return breeding. This guarantee shall only apply if the stallion owner is notified in writing within 72 hours of the foal's death. A statement of details by a licensed veterinarian must follow within 10 days or the guarantee becomes null and void. This clause is also binding in the case of abortion. If the mare resorbs her pregnancy, we need written verification of this fact from your veterinarian.
 - iii) The offered *lifetime* live foal guarantee applies so long as both the mare and stallion described in this agreement remain fertile, maintain their current ownership and an attempt to breed is made each year. Should the conditions for the lifetime live foal guarantee not be met (for example, the mare is sold), an industry standard 2-year live foal guarantee for the 2026 season will be substituted.
- 6) Declaration of the intention to use embryo transfer or ICSI as a means of producing a foal from this breeding must be made clear upon signing of this agreement by checking the indicated box below. Should multiple embryos be recovered, the Mare Owner may decide at their discretion to:
 - a. transfer additional embryos to multiple donor mares with the understanding that a breeding fee will be due for each successfully transferred embryo within 60 days of confirmed pregnancy.
 - b. Mare Owner may freeze additional embryos for future use, in which case an additional breeding fee equal to 50% of the original breeding fee outlined in this agreement will be due for each frozen embryo. There will be no guarantee offered on frozen embryos not transferred into a mare in 2026.

It is the Mare Owner's responsibility to inform the Stallion Owner of any additional embryos at the time of implantation or freezing, which is required for inclusion in breeding reports submitted to all registries for the purpose of future registration of the resulting foal(s).
- 7) This agreement is binding upon the parties herein and reflects the entirety of their agreement.
